Strengthen Transparency and Accountability

Committee Role Description

- The updated draft was included in the June 2019 Council Package
- The meeting adjourned before the motion for the updated policy could be presented
- This will be presented at the September Council Meeting under Business Arising

Policy Review Cycle

- The Executive Committee reviews policy, provides suggestions for update/edit where applicable and Council then follows the process for its approval
- A motion to establish a transparent policy review cycle will be presented at the September Council meeting as per recommendation #33 from the Brown report
 - Recommendation 33: All Board-level Policies of the College will be systematically monitored and reviewed
 - Rationale: Board level Policies would benefit from a refresh and alignment with one another – some are aged, some are Carver, in many cases it is not clear who and when reviewed or approved the policy and when it is next due for review. This review would extend to responsibility for monitoring compliance with each. p. 21
- Onboarding new Council members and Committee members with a framework and a consistent review cycle will strengthening transparency and accountability

Finance Literature

- Thank you to the Finance Committee for providing literature to guide the upcoming budget discussions
- The Chartered Professional Accountants' publication "A Guide to Financial Statements of Not-For-Profit Organizations", provides Council Members with high-level questions to ask during budget presentations

Improve Stakeholder Engagement

Meetings with the Deputy Minister

- I continue to attend meetings between the Registrar and the Deputy Minister, Nancy Naylor
- We met on three occasions (June 17, Aug 7 and Aug 28) to share information regarding Council's governance enhancements decisions
- The government is currently working on regulatory language changes related to the passage of Bill 48 such as the therapy funding and the Math proficiency requirement

Article Contribution to Ontario Principals' Council

- Council member, John Hamilton, upon invitation from OPC extended a co-authoring opportunity for the Registrar and myself
- The submitted article focuses on governance enhancement and the decisions made by Council

Presentation at College of Early Childhood Educators

- The Registrar and I presented to the Council on our Governance Review undertaking
- Questions were posed regarding process as well as content
- CECE Council Members also shared their method of populating Council positions which was shared with the OCT Governance Committee

Summer Focus Groups

- Focus groups were conducted by College staff in six regions for both professional and public members
- Questions focused on professional advisory topics, organizational name, public brochure and College governance
- Several Council Members observed a focus group close to their residence

- Thank you to Council Member, Mary-Anne Mouawad, for presenting on my behalf at the University of Windsor TECH teacher education program in July
- Thank you to Council Members who contributed to a video production that will be shared with final-year Teacher Candidates during faculty presentations
- The video explains the role of self-regulation and how newly licensed OCTs can become involved
